Membership Classifications

All household members may use the Club facilities to the extent that their classification will allow. Household members are defined as the member, their spouse or significant other, the member's and their spouse's children still currently enrolled as a full time student in school and who is living in the member's home, except during the period of time that they are away from home to attend school. Age of the oldest household member determines membership classification.

FULL MEMBERSHIP (Age 40 and Older)

Available to an individual twenty one years of age or older and their household members as defined above. Regular members are entitled to full use of the golf course, disc golf course, swimming pool and all clubhouse services and are subject to all fees and special assessments. Full members are required to purchase one share of stock and shall be entitled to full voting privileges and equity in the Club.

JUNIOR 3 MEMBERSHIP (Age 37-39)

Available to an individual between the ages of thirty seven (37) and thirty nine (39) both inclusive and their household members as defined above. Junior members are entitled to full use of the golf course, disc golf course, swimming pool and all clubhouse services and are subject to all fees and special assessments. Junior members may purchase one share of stock in accordance with the payment plan as of their application date. Upon attaining the age of Forty (40), the Junior member shall become a Full Member, and will receive voting privileges when the stock purchase is paid in full.

JUNIOR 2 MEMBERSHIP (Age 30-36)

Available to an individual between the ages of thirty (30) and thirty six (36) both inclusive, and their household members as defined above. Junior members are entitled to full use of the golf course, disc golf course, swimming pool and all clubhouse services and are subject to all fees and special assessments. Junior members may purchase one share of stock in accordance with the payment plan as of their application date. Upon attaining the age of thirty seven (37), the Junior 2 member shall become a Junior 3 member.

JUNIOR 1 MEMBERSHIP (Age 21-29)

Available to an individual between the ages of twenty one (21) and twenty nine (29) inclusive, and their household members as defined above. Junior members are entitled to full use of the golf course, disc golf course, swimming pool and all clubhouse services and are subject to all fees and special assessments. Junior members may purchase one share of stock in accordance with the payment plan as of their application date. Upon attaining the age of thirty (30), the Junior 1 member shall become a Junior 2 member.

SOCIAL MEMBERSHIP

Available to an individual twenty one (21) years of age or older, and their household members as defined above. Social members shall have no voting privileges and are entitled to full use of the disc golf course, swimming pool, tennis courts and all clubhouse services only and are subject to all fees and special assessments. Additionally, Social Members may play 5 rounds of Golf per year by paying the current fees for golf and carts.

DINING ONLY MEMBERSHIP

Available to an individual twenty one (21) years of age or older, and their household members as defined above. Dining Only Members shall have no voting privileges and are entitled to all clubhouse services only and are subject to all fees and special assessments.

CORPORATE MEMBERSHIP

A Corporate membership may be granted by the Board of Directors to a corporation doing business within the limits as established by the Board of Directors. The business owning such membership shall designate in writing to the Club the employee for whom the membership will be held and the employee must submit application to the Club and must be approved consistent with the membership process . Available to an individual twenty one years of age or older, and their household members as defined above, Corporate Members are entitled to full use of the golf course, disc golf course, swimming pool and all clubhouse services and are subject to all fees and special assessments. The Corporate Membership shall be entitled to voting privileges and may hold Club Office. In the event the membership is transferred, the Corporation shall pay a transfer fee equal to 20% of the current initiation fee.

CORPORATE ASSOCIATE MEMBERS

A designated Corporate Membership may add up to 9 additional employees, **with a minimum of three (3) as Corporate Associate Members**. The business owning the Corporate Membership shall designate in writing to the Club the employee for whom the membership will be held and the employee must submit application to the Club and must be approved consistent with the membership process. Available to an individual twenty one years of age or older, and their household members as defined above. Corporate Associate Members are entitled to full use of the golf course, disc golf course, swimming pool, tennis courts and all clubhouse services and are subject to all fees and special assessments. Corporate Associate Members have no voting privileges and no equity in the Club and may not hold office.

Monthly fee include dues and a \$50.00 Facility Improvement Charge but do not include 8.5% sales tax. A Facility Improvement Charge is assessed to all members and will be used exclusively for the new restaurant, outdoor dining, pool upgrades and renovation to the upper floor.

All dues and fees are payable upon receipt of club statement and will be assessed a late charge of 1.5% if more than 30 days past due.

The new member agrees to the payment of all dues and fees for their membership classification for a minimum period of 12-months, starting on the effective date of their membership. After the initial 12-month period, membership is month to month and may be terminated with a 30-day written notice.

Emporia Country Club offers a challenging 9-hole golf course with 6 sand traps and a 8 acre pond featuring Bermuda grass fairways, Zoysia tees and bent grass greens. With two sets of tees on each the course for Men is 6,309 yards long and plays to par 72, the course for ladies is 5,335 yard par 72.

Beautiful, long, and lots of OB. The Emporia Country Club Disc Golf Course is recognized as one of the premier championship disc golf courses in the United States. Home to the annual Glass Blown Open and the Trilogy Open, the course hosted the 2016 Professional Disc Golf Association (PDGA) World Championship. Featuring the signature 17th water hole the course boasts the toughest finishing holes, you will still have to navigate two par 5's and an island green on your last 3 holes.

For access to the Disc Golf Course you must be a current member of the PDGA or a guest of Dynamic Discs. Please keep in mind that the GBO/Worlds layout is NOT the permanent layout.

Dress Code Policy: Shoes must be soft spikes or flat soled and collared shirts must be worn at all times. Soccer shoes, high heels, western boots, Swimwear, halter tops, tube tops, mid-drift tops, tank tops, spaghetti strap tops, and undershirts alone are all improper attire and will not be allowed at the Emporia Country Club.
